- Managing a Stage Boundary
- Closing a Project

# **PRINCE2 Foundation & Practitioner Examination details**

PeopleCert exams take place remotely via PeopleCert Online Proctoring, and the afternoon of the second and last day of your course will continue with your learning until approximately 17.30pm.
